

Murray Jampolsky Memorial Award for Outstanding Practicing School Counsellor

Criteria

1. Nominee must be a regular member of the ATA Guidance Council.
2. Nominee must be a practicing school counsellor at the time the award is presented.
3. Nominee must meet most of the following criteria:
 - Nominee should be involved in ongoing professional development.
 - Nominee should have initiated innovative project(s) and/or program(s) in school guidance and counselling.
 - Nominee should demonstrate competence in school counselling.
 - Nominee should be involved with the school community in promoting guidance and counselling services.

Nomination Procedure

1. The following individuals may nominate candidates for this award: counsellors, teachers, administrators, students and parents.
2. Each nominee must be supported by three nominators.
3. Nomination forms and supporting documentation shall be submitted by one of the nominators.
4. Submissions must be received by October 15th.
5. The Awards Committee will meet, review applicants and make its recommendation to the Table Officers Committee. An award need not be made each year.
6. The Awards Committee will be composed of three former presidents appointed each year by the Table Officers Committee.
7. The presentation will be made at the Guidance Council's annual conference. The successful candidate will receive
 - full coverage of conference costs (similar to table officers) and
 - a plaque (representative of the trophy maintained at Barnett House by the ATA staff advisor).
8. Nominations shall remain active for three years.
9. A nomination form is printed on the reverse.
